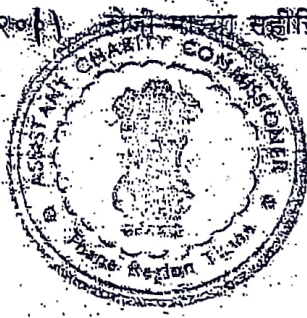

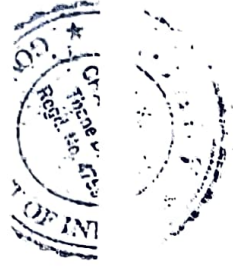
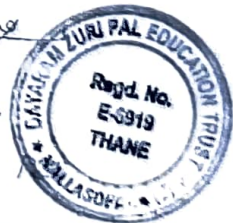
3. The name of the trust shall be known as *Dayaram Zuri Pal* EDUCATION TRUST" and it shall be managed or administered in that name only.

- a) To run educational (School and conduct Vocational courses, for poor and needy student which the association may think desirable to obtain and to carry out exercise and comply with any such arrangements, computer institution etc.
- ✓ b) To establish, promote, set-up, run, maintain, assist finance support or help in setting up or running the schools and other institutions for students and rehabilitation center to the old and aged group of persons.
- c) To provide financial help to the poor and needy students, grant scholarship and other financial helps, required for brightening their future life.
- ✓ d) To arrange educational camps, shibirs, etc., for the benefit of poor and needy student of ruler and urban areas.

- ✓ g) Spread and proposition of education in the society irrespective of caste, creed or community and from this point of view to establish, conduct or take over pre-primary, primary, secondary, technical, higher-secondary educational institutions, college, hostels and libraries and to bring co-ordination in their management and administration.

- h) To arrange and organize various social and religious programs in order to make awareness about importance in the life of general public at large.
- i) To give, provide and/or render education and related assistance and other help and/or assistance in any shape or form to the poor deserving and needy students.

6. To run Environmental Welfare, Educational Activities, Pollution Prevention Programs and developments, Bio Medical waste management program, Pollution Awareness and Activity, Natural Resource Management, Animal Protection Activity and related to human Being Life Cycle.

7. To establish, manage and help religious and spiritual centers including temples for the benefit of public.

8. To do all such other matters and things and to take all such other actions, as may appear to the Trustees to public actions, as may appear to the Trustees to public, but only consistent with and in furtherance of the objects set out these presents. PROVIDED always and also without prejudice to the generally of the foregoing objects that the help to be given under any other foregoing heads wherever the case admits may be given either in the way of pecuniary payments or goods or things or the supply or distribution of foods clothes, medicines, equipments etc. either directly or through any agents or in any mariner which the Trustee may consider desirable.

9. The board shall at its discretion, apply the whole or part of the income of the trust for any one or more of the object mentioned in clause five hereinabove.

10. The trust fund shall be permanent fund and the Board shall be entitled to accept, receive or collect any donation, gifts or contributions, from any person, firm, company, co-operation, association, towards the corpus of the trust or as income of the trust and the Board shall accordingly deal with the moneys so received by the Board or by any other person on its behalf.

11. The control, management and administration of the trust shall be vested in the Board of Trustees and the board shall be entitled to exercise all the powers for beneficial management of the trust and to do all acts, deeds, things necessary for the due performance of the duties entrusted to it.

12. The Board shall take all such steps, legal or otherwise, as regard being has to the nature and amount or value of the trust property, may be reasonably necessary for the preservation of the trust property and/or protection of the title thereto.

13. The Board shall deal with the trust property as care full as a man of ordinary prudence would deal with such property as if it were its own, but the Board shall not be held responsible for any loss, destruction or deterioration caused to or sustained by the trust property in the ordinary course of carrying our the objects of the trust herein.

14. In this deed, unless there is any thing repugnant to the context or meaning thereof:-

i) "BOARD" means the Board of Trustees constituted or virtue of this Deed.

ii) "TRUSTEE" means and included;-

- a) Any person named or appointed as Trustees under or by virtue of this deed and includes the Manager.
- b) Any Trustee/Trustees appointed in terms of this deed.

viii) "TRUST PROPERTY" means and includes the trust fund, trust income and all other property belonging to the trust, i.e. "D. Z. PAL EDUCATION TRUST".

iv) Rule means the rules made under or in terms of this Deed.

v) Words and expressions used but not defined on this deeds shall have the managing assigned to them in Bombay Public Trust Act, 1950.

: SCHEDULES AS REFERRED TO IN THIS DEED :

Without prejudice to the generally of the powers conferred on the board by this deed or by any law for the time being enforce applicable to the trust and without any way limiting, restricting or affecting any such powers or board, the rules hereinafter contained shall govern control, manage and administer of the trust, hereof and for the powers not expressly mentioned hereinabove in this deed but as may be reasonably necessary for carrying out the objects of the trust hereof.

RULES :-

1. **NO. OF TRUSTEES :** The trustees of this deed shall not be less than three or more eleven including manager.

MR. DAYARAM Z. PAL, shall be the first managing trustee on her/his death, resignation, retirement or ceasing to be a trustee, the board of trustees shall appoint a Managing Trustee on the basis of majority of trustee by casting the votes.

2. The terms of the trustees shall be for their life, and any vacancy arising on account of death or resignation the same shall be filled in by the surviving or continuing trustees or trustee by a majority.

3. **MEETING OF THE BOARD :** The Board may meet as often s it deems necessary for the purpose of conducting the affairs of the trust. The meeting shall be held at the registered office or at such place as the Board will decide.

4. **BUSINESS AT MEETINGS** : All matters relating to the trust shall be decided by the board in its meeting by majority.

QUORUM :

1. The quorum for a meeting of the board shall be three trustees.
2. Where in a meeting there is no quorum, the managing trustee of the meeting shall have the discretion to decide any matter as she/he deems fit and proper and any such decision taken by the management (Managing Trustee) shall be deemed to be the decision of the Board.

6. **DISPOSAL OF BUSINESS** : All matters relating to the trust shall be decided at a meeting of the board by a majority of the trustees present and voting.

7. **VOTES** : All the trustees including the managing trustee shall have one vote and in case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have a discretionary power, the votes of the majority, of the trustees for the time being voting in the matter shall prevail and be binding on the majority as well as on these trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the managing trustee or settler.

8. **MINUTES** :

- i) The board shall cause, minutes of all proceeding of the meeting of the board to be entered in books maintained for that purpose.
- ii) The minutes shall contain a fair and correct summary or the proceedings of the meeting.

iii) Where the managing trustee is of the opinion that in the interest of the trust any particular matter should not be included in the minutes, such matter shall not be included in such minutes.

iv) Minutes of meeting kept in accordance with the provisions of this rules shall be evidence of the proceedings recorded therein.

9. ACCOUNTS AND AUDIT :

i) The board shall kept regular accounts of all receipts and movable and immovable property and of all encumbrances created on the trust property and of all payments and alienations made on behalf of the trust.

The account shall contain all such particulars as may be necessary for the preparation of Balance Sheet and Income and Expenditure account or any other Statement that the trust may have to prepare under any law for the time being inforce, applicable to the trust.

ii) The board of trustees shall keep all the liquid assets in one or more bank accounts and shall be entitled to open and operate in any bank from time to time in the name of trust. And any such account shall be operated by any two of the trustees jointly or as may be decided by the board from time to time.

10. POWERS OF THE BOARD : Without prejudice to the powers conferred on the board by this deed or by any law for the time being inforce, the Board shall for the purpose of carrying out the objects of the trust, have the following powers.

- i) To appoint employees on such terms and conditions as the Board may deem fit for day to day routine administration of the trust. The board of trustee can appoint any on one of the trustee or managing trustee as the principal of any of the school of the trust or educational institution of the trust.
- ii) The board shall not be responsible for the defaults of the employees or for any losses incurred to the trust and such employees shall be responsible for such defaults and/or losses.
- iii) To invest subject to any law for the time being inforce applicable to the trust all moneys received by or on behalf of the trust and which can not be applied immediately or at an early date for the purpose of the trust in such manner and in such securities as the board may deem fit.
- iv) To appoint new trustee or trustees either to expend the Board within permissible limits or to fill up any vacancy arising for any reason whatsoever from among the relative of the settlor or of any of the existing or surviving trustees.
- v) To pay out of the income of the trust all the proper costs, charges expenses of and incidental to the management and administration or realization or benefit of the trust property and if there shall be no such income then out of the corpus of the trust to the extent required.
- vi) (a) To apply and expend the said income (or corpus) towards the execution and carrying out of such of the objects and purpose aforesaid.

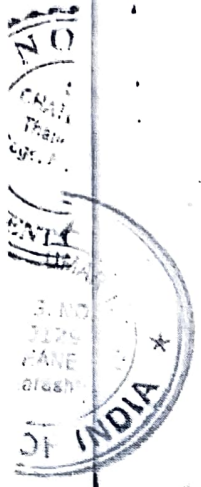

(b) To give aid by way of donations out of the income or corpus of the trust fund or otherwise to different charitable institution, societies, organizations or trust in India which may have been established or which may have hereafter been established.

(c) To invite and receive or without any such invitations receive any voluntary contribution in money or moneys worth either from settlor or form the trustees or any members of members of the public or form any firm, company institution, association or fund.

(d) To accept any composition or security.

(e) To allow any time for payment of any debt due to trust.

(f) To compromise, compound, adondon or submit to arbitration or otherwise settle any debt, account, claim or thing whatever relating to the trust.

(g) To entertain, to give, execute and do such agreement instructions of composition or arrangement or releases and other things as may be necessary without any responsibility attaching to the board for any loss occasioned by any act or thing so done in good faith.

vii) AMENDMENTS : It shall be lawful for the Board of Trustees from time to time to frame such rules and regulations for the management and administration of the trust as they shall think fit and to alter or very the same from time to time and to make new rules and regulations provided that such rules and regulation shall not be inconsistent with terms and intends of these presents.

viii) The affairs of the trust and the trust fund shall be under the management and control of the Board trustees.

11. FUNCTIONS AND POWERS OF THE MANAGING TRUSTEE :

(a) The managing trustees shall look after daily routine work, shall supervise over the educational activities, shall advise the principals of various institutions in their day to day work.

(b) The managing trustee shall look after the correspondence pertaining to the trust affairs. He shall look after the maintenance and un keep of the trust properties, provided that all the functions and powers of managing trustee shall be controlled by the Board of Trustee.

12. DUTY : The board shall administer the affairs of the trust and apply the funds and properties there of for the purpose and objects of the trust or in accordance with the law for the time being inforce applicable to the trust and exercise the seance care as a men of ordinary prudence does when dealing with such affairs, funds or property as if they were her/his/their own.

(b) It shall prepare plans and schemes for carrying out the objects of the foundation from time to time and shall decide upon and resolve the various problems that may arise in the implementation of the plans and schemes.

(c) It shall appoint such staff as is deemed necessary for running the trust at such salaries as it may deem fit, this power to appoint shall include the power to dismiss or re-appoint any member of the staff for reasonable cause.

(d) It shall hold fund arrange for seminars, conference, symposia, lectures and file shows to promote and propagate education etc.

13. REGISTER OF MOVABLE AND IMMOVABLE PROPERTY :

The board or any person appointed by the board shall maintain a register of all movable and immovable properties (not being property of a trebling value) giving all necessary information as may be prescribed by any law for the time being in force applicable to the trust. The register so maintained shall be signed by the managing trustee of the board on behalf of the trustees or as the case may be by the person so appointed by the Board.

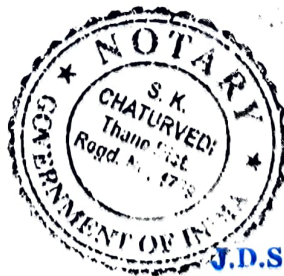
